\*\*\*This Agreement is to be completed by participant or parent/legal guardian if the equine participant is under 18 years of age.

- 1) I have read and understand, and freely and voluntarily enter into this Release and Hold Harmless Agreement with Carlson's Hunters & Jumpers/Hillary Carlson llc. understanding that this Release and Hold Harmless Agreement is a waiver of any and all liability(ies).
- 2) I understand the potential dangers that I could incur in mounting, riding, walking, boarding, and feeding of horses, including but not limited to, any interactions with other horses not owned by myself. Understanding those risks I hereby release, Carlson's Hunters & Jumpers/Hillary Carlson llc. trainers, instructors, clinic assistants, the clinic sponsors, barn owners, managers, and employees, from all claims, demands, action or cause of action of any kind or nature whatsoever, whether now known or ascertained, or which may hereafter develop or accrue me in favor of myself, representatives or dependents, on account of or by reason of any injury (even death), loss, or damage, which may be suffered by me or them, or to any property animate or inanimate, belonging to me or used by me, because of any matter, thing or condition, negligence or default whatsoever and I hereby assume and accept full risk of danger or any hurt, injury or damage which may occur through or by any reason or any matter, thing, or condition, by any person whatsoever.
- 3) I release Carlson's Hunters & Jumpers/Hillary Carlson llc. from any liability whatsoever in the event of injury or damage of any nature (or perhaps even death) to me or anyone else caused by or incidental to my electing to mount, ride, or interact with any horse owned or operated by Carlson's Hunters & Jumpers/Hillary Carlson llc. I understand and recognize and warrant that this Release and Hold Harmless Agreement is being voluntarily and intentionally signed and agreed to.
- 4) I voluntarily agree and warrant to Release and Hold Harmless the equine professionals of Carlson's Hunters & Jumpers/Hillary Carlson llc. from any liability whatsoever, including, but not limited to, any incident caused by or related to said equine professional (s) negligence, relating to injuries known, unknown, or otherwise not herein disclosed; including, but not limited to injuries, death, or property damage from: mounting; riding; dismounting; walking; grooming; feeding; use of horse barn or paddock or trails or horse arenas or obstacle course, in any capacity; falling off horse whether horse is bucking, flipping, spooked; or my failure to understand any equine professional(s) directions related to my riding or otherwise use and control, or lack thereof, of my horse or any horse that I have been assigned to.
- 5) The undersigned hereby consents to give Courtney Carlson of unrestricted use of photographs and videos taken at events, Carlson's Hunters & Jumpers/Hillary Carlson llc. clinics, and all photos and videos taken by Carlson's Hunters and Jumpers and/or any of its subsidiaries or affiliates or sponsors to be used in any news story, article, blogs, Website, Carlson's Hunters & Jumpers/Hillary Carlson llc. DVD labels, TV Shows, publication, or advertising in any kind or in any manner in which above named may decide to use it. This includes any alterations or modifications of said videos or photographs including negatives and prints.

## Stable Rules and Policies

We want to ensure a safe environment for all riders & horses and as well maintain the cleanliness throughout the stable grounds. The following rules and policies are expected to be followed by all riders.

- All riders or persons handling a horse must sign a release before riding and/or boarding any horses in any way.
- NO smoking allowed in or near the barn, hay storage or viewing room at any time.
- NO pets allowed.
- The speed limit on the property is 5 MPH for the safety of horses, riders and children.
- Children 12 and under must be supervised by an adult at all times.
- All Lessee's, Students and Staff are required to wear an ASTM/SEI approved helmet when mounted on a horse for pleasure and instruction.
- Long pants and riding boots with a heel must be worn for riding.
- All visitors/family members accompanying a rider during a lesson must remain quiet and well behaved while at the stable. No one with open toe shoes are permitted around the horses.
- Clean up after your horse and yourself. There are trash containers, shovels, brooms and muck buckets available for the disposal of manure, shedding hair, hoof cleanings and general refuse in the aisle, wash stall, indoor and/or outdoor arena and outdoor grounds.
- Horses will be turned out in specific turnout areas only as directed by instructors. No horses are to be turned out or free lunged in the arena without approval.
- Please do not leave your horse unattended in any area including riding arena.
- Cancellation policy is a minimum of 24 hours notice. If lesson is canceled within this 24 hour period of time, you will be charged for the lesson.
- Lesson package renewal payments are due in advance as outlined... Lesson package of 10-payment is due on the 9th lesson and Lesson package of 20- payment is due on the 19th lesson. This will ensure priority scheduling.
- **All sales are final, there are no refunds, transfers , exchanges** for camps, shows, riding clinics, apparel, lesson packages, etc.
